In the wake of a Tuesday afternoon press conference and a television appearance that night by Hulk Hogan on the Arsenio Hall show which was nothing short of fraudulent, there has been a lot of skepticism brought out regarding Titan Sports' announcement that it will soon be testing its wrestlers for use of anabolic steroids.

We shouldn't get sidetracked away from the real subject at hand by worrying about whether Vince McMahon was telling the truth when he said he only used one steroid (decadurabolin) at one time in his life, some three-and-a-half or four years ago. In the real scheme of things, it doesn't really matter whether McMahon used steroids before. While one can argue they give one an unfair competitive advantage in sports requiring explosive bursts of over or unnatural physical presence, I daresay they don't give anyone an unfair competitive advantage in running a wrestling company. My belief on this subject is if someone wants to use steroids, it's their decision so long as their decision doesn't affect others or their profession in a way that practically forces people who don't want to use them into becoming users simply to stay competitive, or in the case of this business, stay competitive looking. Unfortunately, all the double-talk aside, that is the case in pro wrestling. That is the prime reason why preventive measures are necessary.

We also shouldn't get sidetracked away from the subject by worrying about Hulk Hogan. Hulk Hogan is not the problem. Hulk Hogan is a symptom or a representation of the problem. If Hogan previously took steroids when they were blatantly encouraged by promoters because even before his WWF days because he was pushed harder than almost everyone because of his size, that doesn't make him a bad guy. At the same time, portraying himself as a role model to such a degree may allow him to be judged by a tougher standard. Even if you don't buy that, his actions of late have shown him to be both a liar and a hypocrite. Hogan put on a sorry performance on Arsenio. The idea in that situation must have been that honesty was the worst policy. But dishonesty wasn't such a hot policy, either. What surprised me most, was the reaction to Hogan's appearance within the wrestling business. The business, after all, is a work. However Hogan's saying that he only used steroids three times in his life, when he was champion in 1983 (for the record, he didn't even win the title until 1984), purely as rehabilitation for an arm injury (which he claimed without steroids the injury would have put him out of action for one year, yet Hogan didn't even miss so much as one match with an arm injury in either 1983 or 1984 nor was their any apparent muscle imbalance of one side being larger than the other which happens to lifters who have an injury to one side of the body) drew a vehement negative reaction from almost everyone I spoke with this past week within wrestling. Those in the gym considered it a sorry sham. In football and track lingo, when guys fail a steroid test, they generally invoke what is now known as "The Bosworth Defense," saying they only used the drug once "a long time ago" "to rehabilitate a knee/shoulder." Besides using the Bosworth Defense, Hogan has created a new category, the Hogan Defense, which consists of a guy fingered in court as a steroid user claiming innocence by saying he weighed 196 pounds when he was ten years old (think about how ridiculous that one is, especially those of you with kids who are around ten years old). Newspaper columnists around the country were dubious and critical of his performance. As far as those within wrestling, Bruno Sammartino said largely what you would expect him to say in an article that will appear later this week in the Pittsburgh Post-Gazette. Jim Ross made an indirect remark on his 900 number on Saturday, while once again questioning why WCW doesn't have a steroid policy, bringing up the news of the past week in regards to steroids and again reiterating the problem isn't exclusive to the WWF but then added, "As for those guys who have gone on national television this week and said they only used steroids three times in their life for

medicinal purposes, they're lying and they're risking damaging their career beyond repair." But judging from Hogan's performance, he was desperately trying to save an image that he's obviously afraid is in some trouble and the gates for his matches tell the same story. The think tank must have believed that claiming to have never used steroids except for injury rehabilitation would be better for the image then telling the truth and apologizing. From the pure con-man position of trying to survive the present-day heat without worrying about the future, it was the right choice. Hogan would have taken a lot of heat over the short haul if he had told the truth. But in three weeks, the story would have been finished and he and the WWF would have fixed their so-called achilles heel, the steroid scandal. Instead, Hogan and the WWF are at the mercy of everyone who knows differently to not go public. Quite frankly, going on television with that performance, if it comes out that it was a lie, will be far more damaging over the long haul then having to testify at the Zahorian trial would have been, or telling the truth to Arsenio would have been.

The real issue is Titan Sports' attempt to clean up its steroid problem. When Tuesday was over, my skepticism was very high. It seemed McMahon had decided he needed to give the media a sacrificial lamb, so he consciously picked himself, who nobody buys dolls of or pays ticket money to see, in order to deflect the issue away from his leading meal ticket. However, there is one important point. Vince McMahon knows as well, if not better than anyone else, that his company will survive this story with little long-term damage, provided it only happens once. Having another major round of mainstream attention saying that the problem was just as serious as before, after he has declared his company drug free, would do major damage, particularly when it comes to outside merchandising which probably generates more income for Titan Sports than actually producing the live wrestling events.

Is the WWF serious about steroid testing? It has to be. That much, I'm convinced of. There is simply too much to lose to try and do a work in this situation. On Monday, the WWF interviewed representatives of Comprehensive Drug Testing in Los Angeles, which handled the drug testing in the 1984 Olympics, and currently handles testing for the National Basketball Association, the Continental Basketball Association and Major League Baseball. There was also scheduled to be an interview with Aegis Analytic Laboratories out of Nashville, which handles the National Football League drug testing. Titan Sports expects to receive proposals by about Aug. 1 from those companies and possibly two others before it will set up its program, which includes steroid education and rehabilitation. There are legal issues that need to be worked out as far as wrestlers' contracts, because all previous drug testing (for cocaine) was done in house and when this policy goes into effect, the testing for all drugs will be handled independently.

Is the WWF serious about ridding itself of its steroid problem? Certainly those in the public relations end hope it is. But the real answer to this question won't be known until and unless we see a change in the emphasis on having a muscular physique, education of the audience, and who is being pushed. If we see importance placed on getting to a certain bodyweight in muscular condition, and we see the continuing push on those who look like bodybuilders above those more talented, then whether or not testing is real is a moot point. Tests can be beaten. But if there is no economic benefit to beating the tests, it doesn't matter if they can be beaten. If there is an economic benefit, then they will be beaten sooner or later by everyone. But if there is no benefit attached to beating the test, then Titan Sports should be applauded for its procedure.

In this situation, it is unfair to expect of Vince McMahon and

the WWF something that is impossible. Completely ridding the WWF of steroids is impossible. Getting the problem under control is very possible. No other sport in which the demands include either a muscular physique or explosive bursts of strength or speed has been successful in ridding itself of steroids. The simple reason is because they work. However, pro wrestling does have an advantage over track or pro football if it wants to combat the problem. In pro wrestling, the promoters decide who to push, who wins, who loses, and how they wish to educate the fan. In track, the fastest guy or the guy who throws the object the farthest is going to win and you have to try and continually improve testing to eliminate guys using chemicals to gain a competitive advantage. In football, the best team is going to win. You don't have a booker trying to educate the fans (or in this case, perhaps simply just turning a blind eye to what the fans want and not educating them away from it, which still encourages steroid use) one way or push a certain body type as the ideal.

I spoke this morning with an expert on beating steroid tests. He was the adviser for many Olympic athletes, particularly track athletes, on how to best beat the testing. There are masking drugs. HGH is undetectable. There are new drugs, mainly from Europe, which are so new that there are no tests for them. At the last Mr. Olympia contest, all the contestants were tested for steroids (and five of them were disqualified because they weren't sophisticated enough in the art of beating the tests), all of them were on heavy steroids and most of them passed. Beating a scheduled test, such as in track and how it used to be in football until this season, was simple. You scale down before test day, flush the body out by drinking copious amounts of water, and switch to HGH in the last few weeks. One Observer reader who just got back from winning a silver medal in the U.S. Olympic Festival and spent time with the pentathletes told me this morning that they would come in with suitcases of masking drugs to beat the tests. A seemingly simple thing like drinking Alka-Seltzer can mask most drugs being tested for. Some athletes bring catheter tubes to beat the test. Others, and this has occurred in college football, bring clean urine with them to the testing and make the switch when nobody is looking. In pro football, starting with this season, before every game, eight players chosen at random will be tested. Because one is tested one week in no way changes his odds (roughly five-to-one) that he'll be tested the next week. Because the penalties are stiff enough (six game suspension without pay which is 37.5 percent of an annual salary which for an average player earning \$300,000 per year results in a loss of \$112,500 in annual salary) even the doctor I spoke with, who deals with many pro football players, said that the NFL has been cleaned up. By cleaned up, that hardly means completely clean, but the guys using industrial quantities of numerous drugs are at least toned down to reasonable levels. Of course, while football has its disadvantage over wrestling in that the coaches can't "educate the audience" by putting less muscular men over, it also has a major equalizer. Talent. In football, if you've got superior talent, you'll make it without steroids. Nobody makes these guys take off their shirts and says that if a guy's physique looks like Bobby Eaton's, he can start on the team, but he can't be marketed as a big star even if he's the best player in the league. That isn't the case in wrestling, which is why the problem is worse in wrestling than in any other major sport. Talent is not an equalizer. At least it isn't today.

WWF Vice President Basil DeVito said they have another advantage over football. The NFL has 1,400 players to test. The WWF only has 60 or so. "The more we find out about this subject, the more he learn how difficult it is going to be to implement a fair and reasonable policy." Fair meaning that the wrestlers who are on steroids today need to be given a fair amount of time to get the drugs out of their system. Testing today would be completely unfair to the wrestlers. Oil-based steroids can take as long as six months to get out of ones system. Oral steroids can be taken to beat a test up to about ten days before test time, but it is recommended to insure beating the test to give them about 30 days and the last month before testing sees guys rely on new drugs and/or HGH. It should be four to six weeks before a timetable is set up regarding frequency of tests, if the tests will be random, when they'll start and all other decisions regarding the policy made. Testing of this nature is a fairly costly procedure so getting into this program is a significant step. And even with the grandiose claims about a policy that, as of today, doesn't even exist being superior to any other drug testing procedure in sports, the WWF does have a chance to eliminate the steroid problem in its business. Not eliminate steroids completely, because that is an unattainable goal, but eliminate the problem, which is abuse of steroids being beneficial for a wrestler in terms of his push and income.

There isn't much left to be said regarding the show. This was the single most negative response to any show in the history of this newsletter, and also the largest number of responses to any big-show poll. I'd rate it as the worst PPV event of all-time when everything is considered. Other shows at least had either a few good matches, a few good interviews, or at least in the case of those two Wrestlemanias from Trump Plaza that had very little of either, the booking at least made sense. Depending upon which source one chooses to believe, the buy rate for the show was between a 0.7 and a 1.0, with the most reliable figures being approximately 145,000 orders or a \$2.9 million gross, which would be about an 0.97 buy rate, which is slightly lower than SuperBrawl and one of the lowest, but not the lowest, in company history. The next show is the one where there is danger of a significant fall in the buy rate.

Got the complete line-up for Summer Slam on 8/26 at Madison Square Garden. As already being advertised on television, the main event will be the wedding of Randy Savage and Elizabeth (who have only been married about seven years to begin with). Also already advertised is Hulk Hogan & Ultimate Warrior vs. Sgt Slaughter & Col. Mustafa & General Adnan with Sid Justice as the referee (that match sounds worse every time I type it up), Mr. Perfect vs. Bret Hart for the Intercontinental title, Nasty Boys vs. Legion of Doom for the WWF tag team title, Ted DiBiase vs. Virgil for the Million Dollar belt, Big Bossman vs. The Mountie with the loser having to spend the night in the nearest jail and Bushwhackers with Andre the Giant in the corner against The Natural Disasters. The only matches yet to be announced are IRS vs. Greg Valentine and The Dragon & Kerry Von Erich & British Bulldog vs. Power & Glory & The Warlord with Koko Ware vs. Kato tentatively scheduled as the off-TV dark match (which if they let them work, would be the second best match on the card). This show doesn't have a prayer of doing anywhere near the buy rate of the previous two SS shows. If the wedding doesn't get over huge (and I expect that it will), then the buy rate will be a huge disappointment because there is little else on the show. The Hogan match will end a feud that is already dead, with the only possible interest being who is going to turn on who and the debut of Sid Justice.

An update on the situation in this market. The WWF and WCW are going head-to-head at the Cow Palace and Oakland Coliseum Arena respectively. As of Monday, the WWF advance was a poor 2,700 for a show headlined by Hogan-Slaughter Desert Storm match. The WCW advance was 1,700, which is a lot better than most of the crowds around the horn, but they do have the advantage of being in the key building in this market. This weekend in the advertising on the TV shows, WCW was still advertising Ric Flair, Scott Steiner, Paul E. Dangerously and Missy Hyatt, all of whom aren't going to be there. However, there was a change, in that when Tony Schiavone did a voiceover in one of the squashes, he gave a different card, listing Kevin Sullivan as replacing Flair in an eight-man tag team elimination match (which won't take place as Schiavone announced it since Luger is on the face side and he's a heel and Dusty only knows exactly what Windham's role is) and Rick Steiner teaming with a mystery partner and acknowledging Scott's injury. Hyatt and Dangerously were still being advertised, however. The WWF isn't exactly angels since they were heavily pushing Roddy Piper as being there when he won't be.

Another death of a famous post-World War II "Japanese" wrestler to report. Charles Iwamoto, better known as Mr. Moto in the 50s and 60s and Charlie Moto in the 70s when he worked in the front office for the old Mike LeBelle wrestling promotion in Los Angeles, passed away on 7/6 in Los Angeles at the age of 71. The cause of death was a heart attack. Iwamoto was the first cousin of Duke Keomuka (Duke Tanaka), who passed away just days earlier in Las Vegas after heart surgery. The two were a famous tag team as Hawaiian born heels of Japanese ancestry after World War II. Muto used to book foreign talent for Japanese tours for the old JWA during the 1960s, and his greatest success came in 1963 when he teamed with Kim III (Kintaro Oki) to win the WWA version of the world tag team title from Red Bastien & Bearcat Wright.

EMLL: 7/19 at Arena Coliseo in Mexico City saw heel midgets Jerrito Estrada & Piratita Morgan & Espectrito beat Octagoncito & Mascarita Sagrada & Aguilita Solitaria in two of three falls when a new midget ref called Mini-Davis (this group has a very famous heel ref named Gran Davis) tripped up Sagrada and then didn't call an obvious low blow by Morgan on Sagrada to win the final fall. \*\*\*1/4. This match was to set up a mask vs. hair match between Sagrada and Morgan down the road. Also Tony Arce & Vulcano (Los Destructores) retained their Mexican tag team titles winning 2/3 falls from Plata & Platino (Los Metallicos) in 23:04. \*\*, Apollo Dantes beat Javier Cruz via DQ in a match where Cruz lost both his falls via DQ \*\* and the main event saw Cien Caras & Mascara Ano 2000 & Universo 2000 win 2/3 falls from Rayo de Jalisco Jr. & Lizmark & Atlantis in a real good match \*\*\*1/4. This was the best Galavision show in several weeks. . . Baby Richard beat El Simbolo in a hair vs. hair match on 7/14 at Arena Coliseo. . . Lizmark beat Pierroth Jr. to keep his NWA world lightheavyweight title on 7/18 in Cuernavaca. . . El Egipicio kept his Mexican National heavyweight title beating Blue Demon Jr. on 7/18 in Puebla at the 38th anniversary of Arena Puebla show. . . Lizmark also kept his lightheavyweight title beating Brazo de Oro on 7/17 in Acapulco. . . 7/19 in Guanajuato was headlined by Octagon & Mascara Sagrada vs. Fuerza Guerrera & Emilio Charles Ir. while 7/20 in Acapulco the headline match was Lizmark & Anibal & Pirata Morgan vs. Los Brazos. . . Canadian Vampire Casanova is now the most popular wrestler in the promotion for reasons beyond my comprehension. He's 24 years old and from Montreal and his idol growing up was Rick Martel. He had only a few matches in Canada before coming to Mexico a few months back. . . Negro Casas is said to be joining Blue Panther, Anibal and Los Brazos as those who have jumped full-time to this group, but Yoshihiro Asai is said to have lost interest in jumping.

UWA: 7/14 at El Toreo in Naucalpan saw Canek & The Killer beat Mil Mascaras & Dos Caras in the main event. The two teams were scheduled for a rematch on Sunday, although during the week they were reporting Caras as questionable because of injured ribs and that Fantasma would take his place in that case. . . 7/18 at Arena Pista Revolucion in Mexico City was headlined by Yoshihiro Asai & El Texano & Silver King vs. Rambo & El Indomito & Negro Navarro plus Villano III & Gran

Hamada & Fantasma vs. Fishman & El Signo & Dr. Wagner Jr. . . Same night in Toluca was headlined by Mascaras & Enrique Vera vs. Killer & Pegasus Kid. . . Kokina canceled his tour and will be returning now on 8/18. . . Super Muneco beat Espanto Jr. in a mask vs. hair match in Torreon. . . Perro Aguayo beat Colosso Colosetti on 6/26 in Monterrey in a hair vs. hair match. . . 7/19 in Netzahualcoytol had Mascaras & Hamada vs. Pegasus Kid & Killer, Silver King & Texano & El Drago vs. Rambo & Wagner & Black Power. . . Villano III has a UWA world lightheavyweight title defense against Wagner on 7/23 in Pachuca. . . Lasser has a world lightweight title defense on 7/24 against Ramona Garcia. . . Wrestler Lobo Rubio is the father of Shu El Guerrero. . . Asai and Kendo recorded a record two weeks ago for release in Japan.

ALL JAPAN: A couple of title changes regarding the Asian tag team title this past week. First, Johnny Ace & Kenta Kobashi beat The Can-Am Express (Dan Kroffat & Doug Furnas) to win the titles (not sure in which city) on 7/8, then Ace & Kobashi lost the titles on 7/18 at Tokyo's Korakuen Hall on the Bruiser Brody Memorial show to Joel Deaton & Billy Black. Black & Deaton defend them against Kroffat & Furnas on 7/26 in Matsudo, which may be another title change. . . At the Brody show, they were selling all sorts of Brody paraphernalia (photos, t-shirts, books, etc.) with all the proceeds going to a college scholarship fund for Geoffrey Goodish (Brody's son). They raised several thousand dollars. . . Naturally the card drew a sellout 2,100 to Korakuen Hall as Steve Williams & Terry Gordy & Rick Rude beat Jumbo Tsuruta & Akira Taue & Mighty Inoue, Stan Hansen & Danny Spivey beat Mitsuharu Misawa & Tsuyoshi Kikuchi, Black & Deaton beat Ace & Kobashi when Deaton pinned Ace, Toshiaki Kawada pinned Masa Fuchi, Giant Baba & Rusher Kimura beat Motoshi Okuma & Haruka Eigen, Kroffat & Furnas beat Isamu Teranishi & Yoshinari Ogawa and Joe & Dean Malenko beat Mitsuo Momota & Bobby Fulton. . . NEW JAPAN: This week's big show took place on 7/19 in Sapporo before a full house of 6,350 fans with Big Van Vader pinning Shinya Hashimoto in 18:34 of the main event, Riki Choshu & Tatsumi Fujinami beat Kim Duk & Masanobu Kurisu, Hiroshi Hase & Kensuke Sasaki beat Great Muta (as a heel) & TNT when Sasaki pinned TNT, Bam Barn Bigelow beat Tiger Jeet Singh via DQ, Jushin Liger & Masa Chono beat Mad Bull Busters (Pit Bulldogs in U.S.), The Samoans (Samu & Kokina) beat Masa Saito & Black Cat and Kuniaki Kobayashi & Shiro Koshinaka beat Hiro Saito & Super Strong Machine. . . Most of the emphasis right now is promoting the early August tour. . . 7/20 in Hakodate drew 4,170 as The Samoans & Vader beat Chono & Muto & Choshu when Chono did the job in 8:44, Fujinami & Masa Saito beat TNT & Bigelow, Duk & Singh beat Hashimoto & Kengo Kimura, Hase & Sasaki beat Osamu Kido & Koshinaka, Masashi Aoyagi beat Kurisu via DQ and Norio Honaga & Machine & Tatsutoshi Goto & Hiro Saito bet Cat & Liger & Kobayashi & Kantaro Hoshino. . . 7/21 in Towada drew 2,620 as Saito & Fujinami & Hashimoto beat Mad Bull Busters & Vader,

OTHER JAPAN NOTES: Genichiro Tenryu was named officially as the president of the SWS on 7/19 replacing Hachiro Tanaka. . . Tanaka is start yet a third promotion, which would be the 12th promotion operating out of the Tokyo area headed up by Koji Kitao. Tanaka and their advisers are somehow convinced that since Kitao was such a major celebrity, he can draw wrestling fans in Tokyo but the gimmick of Kitao being a wrestler is long over. . . Tanaka is still puzzled how his 30-member strong SWS can't sell any tickets to shows in Tokyo while the four-member PWF (Pro Wrestling Fujiwara-Gumi) looks like it'll sellout NK Hall this week for the Fujiwara vs. Masaharu Funaki match. . . The reason UWFI is booking so many no-names from the Tennesee area is because the booker is Shinji Sasazaki, who is retired as a wrestler but is living in Tennesee and working in a Japanese restaurant. Interest is already dropping for UWFI because of no decent foreign names, weak main events and live cards that only last 90 minutes with tickets priced at \$57. . . Chris Champion is working for FMW as a Ninja Turtle. . . Reggie Bennett is getting over huge in Japan, more as a celebrity than as a wrestler. Bennett did a TV commercial for a drink called "Da-Dann" which is said to be an Amazon formula energy drink. So they brought in this Amazon woman to be in the ad, jumping out of the water and doing muscle poses and this past week she's been all over regular television talk shows, including this country's version of the Tonight show (Maeda and Fujinami were guests on the show on 7/10) and there are lots of stories on her in the various mainstream magazines and she's made the cover of several. Basically she's caught fire and all the advertising agencies are after her. . . SWS is bringing in Greg Valentine, Demolition and Haku for the September tour. . . SWS is running 8/9 at the 17,000 seat Yokohama Arena with Tenryu & Ashura Hara re-forming their tag team, either to face Yoshiaki Yatsu & Haku (most likely) or possibly the Road Warriors. Either way they'll need plenty of giveaways. The last show at Korakuen Hall (which had two four-star matches on top and no foreign talent and one has a lot to do with the other) drew a legit packed house of 2,297 in the building but only about half was paid. When they were in Sumo Hall in June, the paid attendance was really around 3,000 which is the lowest for any group at Sumo Hall in years. . . Akira Maeda will face former European judo champ Willie Wilhelm on 9/3. It's a rematch of the main event of the November 29, 1989 match at the Tokyo Dome which drew 60,000 fans and set what was then a record with a \$2.9 million gate. . . JWP has several August shows in Tokyo. 8/4 has Miss A & Scorpion vs. Shinobu Kandori & Harley Saito and Rumi Kazama & Mayumi Ozaki vs. Mami Kitamura & Devil Masami. . . 8/8 is the Anniversary card with A & Scorpion vs. Itsuki Yamazaki & Saito, Madusa vs. Masami, Lady X (Peggy Lee Leather) vs. Kitamura, Eagle Sawai & Pink Cadillac vs. Ozaki & Kazama. . . 8/11 has Madusa & Saito vs. Masami & Kazama, A vs. Handa, Lady X & Cadillac vs. Kitamura & Yamazaki. . . 8/30 has an LPWA title match with X vs. Sawai, Masami vs. Yamazaki, Kandori vs. Cadillac and the UWA junior title match with Scorpion defending against Cutie Suzuki. . . 7/14 at Korakuen Hall saw Saito beat Sawai to keep the UWA Intercontinental womens title, Kitamura beat Scorpion, Cadillac & Terri Power beat Kandori &

Yamazaki and Masami & Plum Mariko beat Dementia & Ozaki. . . 7/19 FMW in Sagamihara drew 3,258 with Tarzan Goto & Horace Boulder & The Gladiator beating Kim Chu Hwan (Korean tae kwon do guy) & Atsushi Onita & Sambo Asako in a street fight. . . Finish had Hotta pin Takahashi with a double arm suplex dropped into a power bomb. \*\*\*3/4; 2. Takako Inoue retained her Japanese women's title pinning Sake Hasegawa in 13:36 with a back suplex and pin. It wasn't that smooth at the beginning but they did a lot of nice suplexes toward the end of the match. \*\*3/4; 3. Aja Kong & Bison Kimura beat Toshiyo Yamada & Manami Toyoda in 13:29 when Kong pinned Yamada after a splash off the middle rope. Super fast-paced match with one hot move after another from bell-to-bell. \*\*\*\*; 4. Bull Nakano & Kyoko Inoue beat Mariko Yoshida & Akira Hokuto in 15:31 when Nakano pinned Yoshida after a legdrop off the top rope. Yoshida is a little green compared to the other three but she didn't hurt the match at all. Inoue is the most improved wrestler over the past year that I've seen anywhere. \*\*\*\*

7/6, NEW JAPAN: 1. Kim Duk & Masanobu Kurisu beat Hiro Saito & Super Strong Machine when Duk pinned Saito after a tombstone piledriver in 10:15. Not much in the way of wrestling but Duk & Kurisu hammered their foes with brutal chair shots. After the match Tatsutoshi Goto and Norio Honaga did a run-in and destroyed Kurisu with a chair. \*\*; 2. Keiji Muto & Masa Chono beat Demolition Ax & Canadian Giant in 9:31 when Muto pinned Ax with the moonsault. There was a lot of heat in this match for all the spots which made it an enjoyable match. The Giant is pretty bad, but he was in with such good workers that it was acceptable. \*\*1/4; 3. Tatsumi Fujinami beat Brad Rheingans in 6:21 via submission with the dragon sleeper. Good wrestling, but nothing spectacular and kind of short. \*\*1/4; 4. Riki Choshu & Shinya Hashimoto beat Badnews Allen & Scott Norton in 10:06 when Hashimoto pinned Allen with a mule kick. The match had a lot of heat and was better than it looked to be on paper. It turned into a good match with Norton mainly trying to work hot spots with Hashimoto to set up their singles match. \*\*3/4

7/6, SWS: 1. Apollo Sugawara pinned Road Block with a schoolboy after a missed tackle by Road Block in 8:12. Road Block is pretty bad but he tries hard. \*; 2. In the first match of an elimination tournament, Akira Katayama pinned Hiroshi Hatanaka with a german suplex in 11:17 in a hard-fought match. \*\*\*; 3. Kennichi Oya pinned Katayama with a back suplex in 6:22. \*\*1/4; 4. Ishinriki pinned Oya in 4:17 with the Ishinriki suplex (similar to a back suplex) \*1/4; 5. Kabuki pinned Ishinriki in 3:51 with a backslide. Fast start but the match was too short to build into anything. \*1/2; 6. Kabuki pinned Fumihiro Niikura in 6:27 with a backslide. A fast open but too much time on the mat for such a short match. \*1/2; 7. Kabuki pinned Tetsuya Yamanaka to win the tournament in 5:18 with a lariat. Kabuki gave the rookie, who showed a lot of promise, most of the match. Because of the size difference (Yamanaka is really skinny) the crowd didn't ever see Kabuki as being in jeopardy even though he was on defense throughout. \*1/2; 8. Kendo Nagasaki & Goro Tsurumi & Shogun Wakamatsu beat Don Arakawa & George & Shunji Takano in 18:22 when Tsurumi pinned Arakawa with an elbow drop. Arakawa was beaten on most of the second half of the match. \*; 9. Takashi Ishikawa & Tatsumi Kitahara beat Naoki Sano & Masao Orihara in 19:16. The first ten minutes of the match weren't much with Orihara mainly being pounded on. The last half of the match was super, however. Sano did a Liger-dive over the top rope with a full mid-air flip onto Kitahara. Orihara was then beaten on until past the 15 minute mark when he made the hot tag. Sano did one hot move and near fall after the other. Sano knocked Ishikawa out of the ring. Orihara then did a flying body press off the top rope onto the floor on Ishikawa who was halfway to the

other side of the ring. Sano then did a dive through the ropes on Ishikawa. Kitahara then did a dive over the ropes onto Sano. As they were all brawling, Orihara climbed the top rope and did the moonsault to the floor onto Ishikawa (this is the move of the year, and it better be this year because he's not going to have a long career doing this move in every match). The crowd naturally was going nuts at this point. Back in the ring, Orihara missed a dropkick off the top rope and Ishikawa made him submit to the scorpion deathlock. \*\*\*\*; 10. Genichiro Tenryu & Samson Fuyuki beat Yoshiaki Yatsu & Shinichi Nakano in 14:37. Tenryu was really fired up here and this was the best match since SWS was formed and equal to the quality of the matches Tenryu had when he was with All Japan. All four worked stiff with Nakano taking a real pounding. Yatsu gave both foes several very stiff chair shots, including busting Fuyuki open and he bled like crazy. Yatsu then attacked Akihiro Mikate, a young guy being trained by Tenryu, who was outside the ring, with a chair. Both teams did some innovative maneuvers here, particularly Kroffat. Finally Furnas pinned Rogers with the Frankensteiner, actually doing the move better than Scott Steiner. \*\*\*\*; 2. Mitsuharu Misawa & Toshiaki Kawada beat Jumbo Tsuruta & Yoshinari Ogawa. Ogawa took a ton of punishment since he's so much smaller than everyone else. Still, his offense was solid and the crowd popped for everything. It was another great match. Kawada had a bloody nose from Ogawa's kicks. Kawada got all fired up and destroyed Ogawa with a power bomb for the pin and kept kicking him after the match. \*\*\*\*; 3. Steve Williams & Terry Gordy regained the PWF world tag team titles beating Dan Spivey & Stan Hansen. This match went more than 20 minutes. It was slow paced because it went so long but the work was very stiff. Gordy took a real beating from Hansen's chair shots. Turned into an exciting match, although very different from the previous two. Gordy ended up pinning Spivey with a rolling reverse cradle. \*\*\*1/2

7/13, NEW JAPAN: 1. Mitsuhiro Matsunaga beat Masashi Aoyagi when the ref stopped the match as Aoyagi had Matsunaga in a judo armbar in 7:28. Both of these guys are martial arts guys and Matsunaga is actually a protege of Aoyagi and they started together with FMW. Very little heat. Matsunaga's offense didn't look convincing, and since he was on offense almost the entire match, that tells about the match. 1/2\*; 2. Choshu & Fujinami beat Ax & Giant in 7:26 when Fujinami pinned Giant with a sunset flip. The best thing I can say about this is Giant is better today than Andre would be today, but this was pretty bad. 1/2\*; 3. Norton pinned Hashimoto in 11:13 with a powerslam. This match should have had a lot of heat since they both have "tough-guy" reps with the fans and a unique presence. But it was a dull match most of the way since neither really have the ability to carry the other. \*; 4. Muto & Chono beat Hiroshi Hase & Kensuke Sasaki in 31:05. The last 11 minutes aired on television. This card was taped in a building that was about 100 degrees and humid and all four were very tired and drenched in sweat. USWA: 7/15 in Memphis saw Rob Zakowski beat Sabu, Bill Dundee beat Judge Dread, Dirty White Boy & Dirty White Girl beat Miss Texas & Tom Prichard via DQ when Eric Embry interfered and threw White Girl into the mud hole, Jeff Jarrett & Robert Fuller regained the USWA tag team titles beating The Bar Room Brawlers (Jeff Sword & Doug Vines), Eric Embry won a hair vs. hair handicap match beating referee Paul Nabors & Eddie Marlin so both Nabors & Marlin got their heads shaved and Jerry Lawler pinned Leatherface, who wasn't either Tex Sallinger (who is back in Florida) or Brian Lee. . . New to the area is Heartbreaker Randy Harris, who appears to be a rookie and Awesome Kong, managed by Reggie B. Fine, who was trained by Killer Brooks in Texas and is a 400+ pounder. Fine is using the telephone gimmick, which is at least original. . . 7/22 in Memphis has Randy Harris vs. Doug Gilbert (so I guess Gilbert is still around), Danny Davis vs. Brian Christopher for the lightheavyweight title, Prichard vs. Dundee for the Texas title, In a Bar

Jim Neidhart is back on the road full-time replacing Jake Roberts (injured neck) and beating Earthquake everywhere. . . There has been talk that Quake has given his notice which may explain that result. . . LOD Hawk returned to action after being out two months with a herniated disc over the weekend, however Mr. Perfect is still out of action with a bad back. . . Perfect is supposed to take a few months off after Summer Slam to let his back heal up. . . Hogan is also taking time off after Summer Slam and won't return until late October because he's doing a movie. During the interim, WWF is only going to run one show per night headlined by Warrior vs. Undertaker (Undertaker, who is the group's hottest character, isn't even on the Summer Slam lineup) in either coffin matches or body bag matches. . . 7/12 in Winnipeg drew 5,500 as The Dragon (Ricky Steamboat) pinned Brooklyn Brawler, The Berserker pinned Jimmy Snuka, Bret Hart drew with IRS, Rockers beat Beverly Brothers (very good match), Animal pinned Brian Knobbs, Virgil pinned Ted DiBiase and Ultimate Warrior beat Undertaker via DQ (crowd was cheering 50-50 for both guys). . . The Mountie made his first Canadian appearance since the deal was struck with the Mounties on 7/21 in Toronto. He came out with shorts and a t-shirt on, billed simply as Jacques Rougeau. . . 7/21 in Toronto saw Warrior beat Undertaker in a

body bag match, Rockers & Virgil beat Orient Express & Mr. Fuji, LOD beat Nasty Boys via count out in a no DQ match, Rougeau pinned Bossman, IRS pinned Greg Valentine, Hart pinned Dino Bravo and Berserker pinned Ware. . . An update on the situation in this area with KTVU, Ch. 2. KTVU will continue to air shows of both WWF and WCW. The WWF Superstars show will remain on Saturday at 11 a.m. Wrestling Challenge will be added in August and World Wide Wrestling will remain but the station hasn't decided on time slots for either show. Most likely they'll be put in a two-hour block from 10 a.m. to Noon on Sunday. . . Prime Time Wrestling drew a 3.1 rating on 7/15 while All-American did a 2.3 on 7/14. . . The one show Hogan did appear on was 7/18 in Cleveland which went head-to-head with the WCW show in the same city. WWF drew 6,500 and \$80,000 while WCW drew around 800 and \$9,500. . . Ned Brady, who works for Eddie Mansfield in Florida, can no longer use the name Repo-Man. Apparently one of Brady's friends called J.J. Dillon with the Repo-Man idea and while the WWF didn't use the idea, they trademarked the idea and aren't allowing Brady to use it. . . Depending upon who you talk with this week, some wrestlers have been told by the office that the steroid testing will be legit and to get off the stuff immediately and others haven't been contacted yet. Some are unhappy about it, others feel differently. . . 7/19 at the Capital Centre in Landover, MD drew 6,500 as Berserker beat Ware, IRS beat Valentine, Bushwhackers & Virgil beat Orient Express & Fuji, Kerry Von Erich double count out with Warlord, Nasty Boys double count out with Rockers, Neidhart pinned Earthquake and Warrior beat Undertaker. . . 7/18 in Omaha drew 3,500 as Berserker beat Ware, Valentine beat Bravo, Hart beat Barbarian, Duggan beat Warlord, Neidhart beat Earthquake, LOD beat Nasty Boys via count out and Warrior beat Undertaker. . . 7/20 in Philadelphia at the Spectrum drew 10,000 as Bravo beat Ware, IRS beat Valentine, Hart beat Haku, LOD beat Nasty Boys via DQ, Bossman pinned Mountie, Rockers & Virgil beat Orient Express & Fuji and Warrior beat Undertaker via DQ. . . 7/20 in Lexington drew 4,800 as Von Erich double count out with Warlord, Neidhart pinned Earthquake, Berserker pinned Snuka, Duggan pinned Mustafa, Bushwhackers beat Power & Glory, British Bulldog beat Typhoon and Savage beat Slaughter in a Desert Storm match when Adnan threw in the towel. . . 7/20 in Louisville drew 3,700 as Warlord pinned Snuka, Duggan pinned Mustafa, Bulldog pinned Typhoon, Bushwhackers beat Power & Glory, Von Erich double count out with Berserker, Neidhart pinned Earthquake and Savage beat Slaughter via submission with the camel clutch in a Desert Storm match. . . Andre now needs two canes to walk to the ring.

WCW: The first issue of the new WCW Magazine hits the newsstands on 8/6. . . Jim Ross spent six hours in the emergency room with kidney stones after the PPV show. . . James Oshust, who was the guy responsible for WCW getting into several buildings including the Arena in St. Louis and the Oakland Coliseum Arena, will be through at the end of August because his position is being eliminated. Jim Barnett is handling booking of the buildings. WCW didn't produce when given the chance. It's expected they won't be able to book another date at the Oakland Coliseum Arena after Friday (although they do have a date at the Kaiser Convention Center in Oakland in September). They are also said to be out of the Arena in St. Louis after the October date and out of the Charlotte Coliseum after the August date. . . No word on steroid testing although upper management has had talks about the subject. . . They had about a four-star match on World Wide this weekend with Yellow Dog & Bobby Eaton & Dustin Rhodes beating Barry Windham & Arn Anderson & Diamond Studd. . . Big Van Vader scheduled to return in October. . . Can anyone give me a logical explanation as to why the same upper management (Jim Herd in particular) is still in charge of this company? . . . 7/16 in Farmland, IN drew 960 as Johnny B. Badd pinned Mike Graham, Steve Austin pinned Eaton (best match on card), P.N. News beat One Man Gang via DQ, Young Pistols & JFD beat Richard Morton & Terrence Taylor & Thomas Rich and Yellow Dog & Sting beat The Hard Liners. . . Barry Windham missed a few mid-week dates resting up his injured ankle or knee. The match that aired on WCW on Saturday with Black Bart was where the injury took place and his leg caught the rope going over on a backdrop. He was back in action by the end of the week. . . Black Blood also missed a few more shots with his bad knee. . . NBC's George Michael Sports Machine, which is about the only outlet that gives this group any national coverage, aired an interview with Jim Herd on Sunday night after the Baltimore show (Flair declined the interview on advice from his lawyer, some expect a suit will be filed against WCW) where Herd said that nobody was sadder than he was to (continued on page 10)

May Jim Herd and Dusty Rhodes follow the Yellow Brick Road to bankruptcy and end this folly once and for all. All the boys left at WCW, pay close attention to the respect loyalty derives from your company. Sting and Sid must have had the right attitude all along. I should have been shot to have been so optimistic when Rhodes was announced as new booker. Sure, anything was better than Ole Anderson, but as it turns out, it was like the doctor saying that your cancer is in remission only to later find out you've tested positive for HIV.

I talked with Barry Norman (WCW p.r. rep) on the Ric Flair situation and his comments were unbelievable. He said it was a farce that the Charlotte Observer called for a boycott of WCW. First off, they might cheer now because the general public doesn't like Canseco, but they were asking Flair to take a cut on an existing deal. If the Rangers pulled the same stunt with Nolan Ryan, everyone would be outraged. Norman said that Ric Flair can't draw like Nolan Ryan and then changed the subject when I asked him who does WCW have that will draw as champion.

#### Mark Nulty Atlanta, Georgia

I heard the news today about Ric Flair being fired and was stunned. To a vast number of fans, Ric Flair meant pro wrestling. I was sitting around at work thinking about this shabby treatment of a genuine legend and if I was employed by WCW, I would never feel like letting them be in control of my career. Egos aside, Ric Flair should have at least been allowed to bow out with grace.

This happened because pro wrestling has no sense of history. Wrestling is a shameless treadmill that considers its wrestlers as products

They worry about their health and working conditions. We constantly point to the risks of steroids. The promoters don't care. They want the wrestlers to pump themselves up with juice and abuse them until they have no usefulness, then discard them. This is a sad indictment of a profession. Ric Flair was the consummate pro wrestler and did everything in his power to put fans in the seats. I hope WCW is content with themselves and their direction. The days of glory are over. Grind those wrestlers up and spit them out. They don't even realize that a quality athlete can't be replaced by a group of mindless cardboard cartoon characters.

The WCW has finally done it. They have destroyed the 43-year legacy of the NWA and truly discouraged all of their fans. No, it was something far more important than any of those. It was Ric Flair leaving WCW. As a hardcore Rotisserie league owner, I know what it's like to overreact to relatively unimportant events. Abrams called him a few days after the show and asked him to promote the 7/20 television taping, but he refused, citing he didn't want to be related with that organization anymore.

While I don't disagree in that the build-up got out-of-hand at times, you don't build something up for six months, then pull the plug on it right as it's about to hit the house shows, particularly when it is being advertised and you aren't changing the advertising. . . The sad part about all of this is that most people don't even get mad about this, they just don't even care enough about the promotion where it makes a difference. . . 7/21 in Knoxville drew 1,200 as Freebirds beat Desperados, Zenk pinned Studd, Badd pinned Rich, Rhodes pinned Morton, Anderson pinned News, Yellow Dog beat Windham, Austin beat Eaton, Gigante won Battle Royal and Steiner & Simmons beat Hard Liners in a cage match. . . There were "We Want Flair" chants this week at some of the shows, but not at all of them, even though Flair was never advertised on these shows except probably for Cleveland. . . This week in California saw the 7/25 show in San Bernardino already be canceled because the advance as of the weekend was only 100 tickets. The San Diego for Wednesday advance was just over 200 tickets but that hasn't been canceled. The 7/23 show at the Forum in Los Angeles had an advance of around 1,000 tickets. . .
